It is hereby certified that:

- 1) The name of the proposed corporation is Walden Enterprises Incorporated.
- 2) Walden Enterprises Incorporated is a perpetual corporation.
- 3) The aggregate number of shares which the corporation shall have the authority to issue is Two hundred (200) shares no par.
