

ARTICLES OF INCORPORATION  
of the  
SHAW MOUNTAIN GOLD MINING COMPANY, Limited.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, H. H. Rand of North Greenfield, County of Milwaukee, State of Wisconsin, and John R. Bowen of Chicago, County of Cook, State of Illinois, and Mrs. R. E. Green, and George McIntyre, and R. W. Purdum of Boise, County of Ada, State of Idaho, have this day associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify as follows, to wit:

I

That the name of the said corporation shall be "The Shaw Mountain Gold Mining Company, Limited";

II

That the purposes for which this corporation is formed, are to purchase, control, operate, and sell, those certain mining properties situate, lying and being in the "Shaw Mountain Mining District" in Boise County, State of Idaho, said properties being known as the "Rising Sun Vein or Lode" and the "Paymaster Vein or Lode", and for the purpose of transacting a general mining and milling business in the aforesaid counties of Ada and Boise;

III

That the place where the principal business of the said company shall be transacted, shall be in Boise, County of Ada, State of Idaho, and that the principal office of the said Company shall be in the said City of Boise, and that the mining and milling business of the said company shall be carried on in either of the aforesaid counties of Boise, and Ada;

## IV

That the term for which said corporation is to exist shall be fifty years from and after the date hereof;

## V

That the number of the directors of said corporation shall be five and the names and residences of those who are to be appointed for the first year, are the following, to wit:
