



# ARTICLES OF INCORPORATION

OF

#### H & R BLOCK, INC.

We, the undersigned, being natural persons of full age and subscribers to the shares of the corporation to be organized pursuant hereto, for the purpose of forming a corporation under Title 12 of the Louisiana Revised Statutes of 1950, as amended, do hereby adopt the following Articles of Incorporation:

#### ARTICLE ONE

The name of the corporation is: H & R BLOCK, INC.

#### ARTICLE TWO

The purposes for which the corporation is formed are:

- (1) To perform tax services, including the preparation of tax returns; to render bookkeeping services, including the preparation of books of account, balance sheets, and profit and loss statements; and to perform any and all other services directly or indirectly related thereto; and
- (2) To purchase, lease or otherwise acquire, hold, own, establish, operate, sell and otherwise deal in, franchises of firms and persons engaged in the business of rendering tax services and preparing tax returns.

#### ARTICLE THREE

The term for which it is to exist is 99 years.

#### ARTICLE FOUR

The location and post office address of its registered office in the State of Louisiana is: 2828 Plank Road, Baton Rouge 5, Louisiana.

## ARTICLE FIVE

The full name and post office address of each of its registered agents is: (1) Lewis L. Gilliland, 185 Gloria Drive, Route 1, Baton Rouge, Louisiana, and (2) Shirley A. Gilliland, 185 Gloria Drive, Route 1, Baton Rouge, Louisiana.

#### ARTICLE SIX

The total authorized number of shares which the corporation shall have authority to issue shall be Two Hundred (200), all of which shall be common stock having a par value of One Hundred (\$100.00) Dollars per share, amounting in the aggregate to \$20,000.00.

There are no preferences, qualifications, limitations, restrictions, or special or relative rights with respect to these shares.

# ARTICLE SHYEN

The amount of paid-in capital with which the corporation will begin business shall be One Thousand (\$1,000,00) Dellars in lewful money of the United States.
