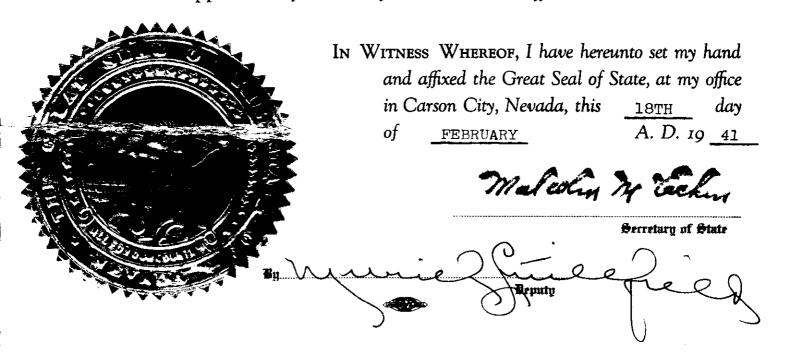

KNOW ALL MEN BY THESE PRESENTS:

ors, adopted at a meeting of said Board duly called and held for the purpose of passing on said resolution, a special meeting of the stockholders of INLAND EMPIRE REFINERIES, INC. a corporation organised and existing under and by virtue of the laws of the State of Nevada was held at the office of the corporation in Salt Lake City, Utah, on the Slat day of January, 1941, after due and legal notice had been given to the stockholders in conformity with the requirements of the Articles of Incorporation and the laws of the State of Nevada, at which said meeting 87,347 shares, or in excess of eighty-eight per cent (88%) of the capital stock of the said corporation was represented in person and by proxy. Thereupon the articles of incorporation of the corporation were amended by the adoption of the following resolutions by the unanimous vote of all of the stock of the corporation represented at said meeting:

BE IT RESOLVED, that Article IV of the Articles of Incorporation of this corporation shall be amended to read as follows:

ARTICLE IV

That the maximum number of shares with nominal or parvalue which this corporation is authorized to have outstanding at any time is One Hundred Fifty Thousand (150,000), all of which shall be common stock of the par value of Ten Dollars (\$10.00) each.

AND BE IT FURTHER RESOLVED, that the President or Vice President and Assistant Secretary of the Corporation be and they are hereby authorized and instructed to file in the office of the Clerk of Washoe County, State of Nevada, and of the Secretary of State of the State of Nevada, the amendment to the Articles of Incorporation as therein provided.

In conformity with the above resolutions and as required by law, we, the Vice President and Assistant Secretary, respective-

ly, of INLAND EMPIRE REFINERIES, INC. have executed this instrument and do sign and verify the same for and on behalf of the Corporation, this 4th day of February, 1941.
