ARTICLES OF INCORPORATION

OF

RAINBOW CEDAR, INC.

We, the undersigned, all of whom are of full legal age and citizens and residents of the United States of America and the State of Idaho, do hereby voluntarily associate ourselves for the purpose of forming a private corporation for the purposes hereinafter stated under the laws of the State of Idaho, and do hereby set forth, declare and certify as follows:

I.

The name of the Corporation shall be Rainbow Cedar, Inc.

II.

The purposes of the corporation are to engage in the purchase, sale and manufacture of wood, lumber, and wood products of every type and nature and generally deal in the business of lumbering and lumber manufacturing; to acquire and hold any and all types of real and personal property of whatever nature related thereto or used in anywise in connection with the manufacturing of wood products and generally engage in all types of business endeavors associated with the manufacture and milling of lumber and lumber products.

III.

The duration of the corporation is to be perpetual or until duly dissolved by the members thereof in accordance with the laws of the State of Idaho.

IV.

The location and registered address of said corporation is Santa, Idaho.

The total authorized number of par value shares of stock is 500. The aggregate par value of said shares is \$50,000.00.

VI.

The stock of the corporation is divided into 500 shares of common stock having a par value of \$100.00 per share, and each share shall be in all respects equal to every other share.
