**ARTICLES OF INCORPORATION  
OF**

I, the undersigned, a natural person of the age of eighteen (18) years or more, acting as the incorporator of a corporation under Title 30, Chapter 1, of the Laws of the State of Idaho, adopt the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation (which is hereinafter referred to as the "Corporation") is

**TOMMYVISION CORPORATION**

**SECOND:** The period of duration of the Corporation shall be perpetual.

**THIRD:** The purposes for which the Corporation is organized are as follows:

(a) To design, create, market and deliver computer-based planning, registration and badging, database and lead-generation, electronic mail, videotext, advertising, and electronic, bulletin-board, as well as other services to convention, trade show and meeting organization, and further, to create, market, and deliver computer software applications, training, and consulting services; and

(b) To have and exercise any and all powers and privileges now or hereafter conferred by the general laws of the State of Idaho upon corporations formed under such laws.

The foregoing enumeration of the purposes of the Corporation is made in furtherance and not in limitation of the powers conferred upon the Corporation by law. The mention of any particular purpose is not intended in any manner to limit or restrict the generality of any other purpose mentioned, or to limit or restrict any of the powers of the corporation. The Corporation shall have, enjoy and exercise all of the powers and rights now or hereafter conferred by the laws of the State of Idaho upon corporations of a similar character, it being the intention that the purposes set forth in each of the paragraphs of this Article shall, except as otherwise expressly provided, in no wise be limited or restricted by reference to or inferred from the terms of any other clause or paragraph of this or any other Article of these Articles of Incorporation, or of any amendment thereto, and shall each be regarded as independent, and construed as powers as well as purposes; provided, however, that nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business or exercise any power, or do any act which a corporation formed under the general laws of the State of Idaho may not at any time lawfully carry on or do.

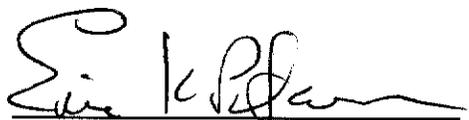

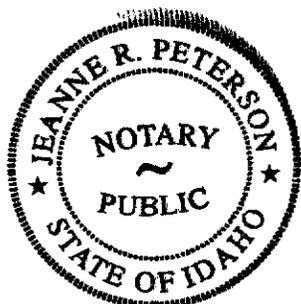
