## ARTICLES OF INCORPORATION

OF

## GUTTERUD ENTERPRISES, INC.

KNOW ALL MEN BYTHESE PRESENTS: That we, undersigned, being all bona fide citizens and residents of the United States of America, and each being over the age of eighteen (18) years of age, do under and in pursuance of the general corporation laws of the State of Idaho, hereby organize, constitute and associate ourselfs and such other persons as may hereafter become associated with us into a body politic and corporate, and to that end execute the following ARTICLES OF INCORPORATION, and we hereby set forth and declare as follows:

I.

The name of this corporation is and shall be GUTTERUD ENTERPRISES, INC. The registered office shall be 234 South 19th, Pocatello, Idaho 83201, and the registered agent shall be ROSS GUTTERUD, with the same address as the registered office.

II.

The term of existence of this corporation shall be perpetual.

:

The principal place of business and office of this corporation shall be 150 North Main, Pocatello, Idaho 83201, and that other offices for the transaction of business of corporation shall be established by the Board of Directors from time to time, both within and outside of the State of Idaho, and that the meetings of the Board of Directors may be had pursuant to the provisions of the By-Laws at the principal office or at such other places as the By-Laws shall provide.

IV.

The purpose for which this corporation is formed are as follows: Any and all lawful purposes allowed under the laws and statutes of the State of Idaho.

V.

The corporate powers, business and property of the corporation shall be exercised, conducted and controlled by a Board of Directors, who shall be elected by the stockholders in accordance with the By-Laws, and who shall have the power to repeal, amend and adopt new By-Laws of and for the corporation, and to hold their meetings pursuant to the provisions of the By-Laws, and at such places and at such times as the said Board of Directors may, be resolution, direct or by act of the Board fix, both within and outside the State of Idaho.

#### VI.
