

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned incorporators do hereby certify that we have this day voluntarily associated ourselves together for the purpose of forming a co-operative association, under and in compliance with I.C. 22-2601 et seq., and do hereby adopt the following articles of incorporation, to-wit:

ARTICLE I.

The name of this co-operative association shall be NORTHWESTERN CO-OP ASSOCIATION, INC.

ARTICLE II.

The purposes for which this co-operative association is formed are:

(a) To transport agricultural products for members and non-members.

(b) To do all other things as allowed by Idaho Code 22-2606, which is incorporated herein by reference, and made a part of these articles.

ARTICLE III.

The principal place of business of this co-operative association is 216 Eighth Street North, Nampa, Idaho 83651.

ARTICLE IV.

The term of existence of the co-operative association shall be a term of fifty years.

ARTICLE V.

The association will not issue common stock, but will admit members under the terms and conditions prescribed in its by-laws.


