natural persons of full age and citizens of the United States  
of America, have this day voluntarily associated ourselves  
together for the purpose of forming a corporation under the

I.

That the duration of this corporation is perpetual.

III.

That the place of business of this corporation and home

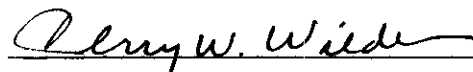
The initial Board of Directors shall be the incorporators. That the Board of Directors shall consist of three (3) directors and the stockholders will also be Board of Directors.

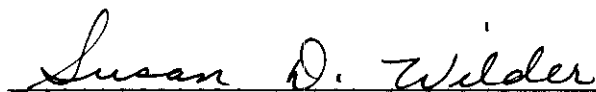
VIII.

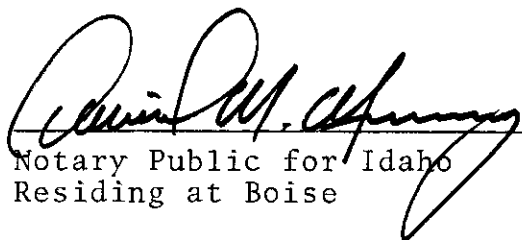
