ARTICLES OF INCORPORATION

OF

BOISE ANGEL ALLIANCE, INC.

The undersigned, acting as incorporator of Boise Angel Alliance, Inc., a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of the corporation is Boise Angel Alliance, Inc.

ARTICLE II.

The period of its duration shall be perpetual.

ARTICLE III.

The corporation is organized exclusively as a business league within the meaning of and pursuant to Section 501(c)(6) of the Internal Revenue Code of 1986 (or under the corresponding provision of any future United States Internal Revenue law), including, for such purposes, but not limited to, providing a forum for accredited investors and emerging companies to meet and exchange ideas regarding new and traditional investment structures used in the investment industry, new and existing approaches to investment transactions, and general IDAHO SECRETARY OF STATE methods of increasing efficiency in various types of investment transactions. 58.616 TRANSACTION OF STATE 18.88 = 38.88 INC NONE EXPLICIT 18.28.88 = 38.88 INC NONE EXPLICATION INCOME.

Articles of Incorporation to the "Code" shall be to the Internal Revenue Code of 1986, as amended from time to time

ARTICLE IV.

- A. No part of the income or net earnings of the corporation shall inure to the benefit of, or be distributable to, any member, director, or officer of the corporation or to any other private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes, and reimbursement may be made for any expenses incurred for the corporation by any officer, director, member, agent or employee, or any other person or corporation, pursuant to and upon authorization of the Board of Directors).
- B. No member, director, or officer of the corporation, or any other private individual shall be entitled to share in any distribution of any of the corporate assets on dissolution of the corporation or otherwise. Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation to such organization or organizations as may then be recognized by the Internal Revenue Service as described in Sections 501(c)(3) or 501(c)(6) of the Code, as the Board of Directors shall determine.
- C. Notwithstanding any other provision hereof, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization which is tax exempt under the provisions of Section 501(c)(6) of the Code.

ARTICLE V.

The corporation shall have no voting members and all business affairs of the corporation shall be conducted by its Board of Directors.

ARTICLE VI.
