

ARTICLES OF INCORPORATION
OF
ECHO INC.

The undersigned, acting as incorporators of a corporation under the General Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Echo, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which this corporation is organized is primarily to be engaged in the business of operating a liquor-by-the-drink lounge; However, this corporation is authorized to transact any or all business or businesses which is lawful for which any corporation may be incorporated under the Idaho General Business Corporation Act as set forth in Title 30, Chapter 1 of the Idaho Code, as enacted in 1979, and as thereafter amended.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is One thousand (1,000) shares, all of one class, and having a One Hundred (\$100) Dollar per share par value.
