

Articles of Incorporation of the
Silver Bullion Gold-Silver Mining
Company

Article 1st The name of this Incorporation and
by which it shall be known is
the Silver Bullion Gold-Silver
Mining Company

Article 2nd The object of this Incorporation and
the business in which it proposes
to engage is the working and
development of the original or
discovery claims known as the "Silver
Bullion" Gold-Silver Quartz Lode
situated in Carson Mining District
Owyhee County Idaho Territory and
consisting of eight hundred undivided
feet

Article 3rd The amount of Capital Stock of
this Incorporation shall be one
hundred and sixty thousand dollars
in eight hundred shares at two
hundred dollars each

Article 4th The principal office of this Incorporation
shall be at Ruby City Owyhee
County Idaho Territory

Article 5th This Incorporation shall exist for
the term of fifty years

Article 6th The Board of Trustees of this Incorporation
shall consist of three who shall
transact the business of the Company
and manage its concerns for the first
six months from the date of this
certificate, and until their successors
are elected and qualified.
