ARTICLES OF AMENDMENT OF CALDWELL BMX RACEWAY, INC.

Pursuant to Section 30-3-93 of the Idaho Code Caldwell BMX Raceway, Inc. adopts the following articles of amendment to its articles of incorporation:

1. The name of this corporation is **CALDWELL BMX RACEWAY, INC.**

2. The amendments hereinafter stated were approved by the members of the corporation on February 16, 2002, in the manner prescribed by the laws of the State of Idaho and the Articles of Incorporation of Caldwell BMX Raceway, Inc.

3. The articles amended are hereinafter set forth:

"ARTICLE IV - MEMBERS AND MEMBERSHIP MEETINGS

1. This corporation shall have Members, whose qualifications, manner of election to membership, rights, privileges, and voting rights shall be as provided in the By-Laws.
2. The affairs of the corporation shall be managed by a Board of Directors consisting of not less than three (3) nor more than nine (9) directors to be elected by the members.
3. Annual and regular meetings of the members shall be held in accordance with Section 30-3-46 of the Idaho Code, at such times and places as may be provided in the By-Laws. Notice of all membership meetings shall be given in the manner provided in the By-Laws.
4. The members actually present at any duly called membership meeting shall constitute a quorum,


1 regardless of their number, and may transact any
2 matter of business permitted to be transacted at a
3 membership meeting of a non-profit corporation, and
4 may also transact any matter of business permitted by
law to be transacted by a Board of Directors of a
non-profit corporation.


- 5 5. The vote of a simple majority of the members present
6 and eligible to vote at any membership meeting shall
7 be sufficient to carry the proposition being voted
8 upon, unless a higher majority be required with
9 respect to the specific proposition by law, by
express provision in these Articles of Incorporation,
or in the By-Laws.

ARTICLE V - OFFICERS

11 The officers of the corporation shall be a President,
12 Vice President, Secretary and Treasurer. The officers of the
13 corporation shall be elected by the Board of Directors
annually or at a meeting called for such purpose."

the 16th day of February 2002.



legal guardian.


The number of adult members and non-adult members of the
