ARTICLES OF INCORPORATION OF

THREE HEARTS-THREE HANDS, INC. 8: 29

The undersigned, acting as incorporator of a non-profit corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

The name of the corporation is THREE HEARTS-THREE HANDS, INC.

This corporation is a non-profit corporation. That *Three Hearts-Three Hands, Inc.*, was formed in 2002 and operated as a non-profit organization.

This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal tax under Section 501(c)(3) of the Internal Revenue Code.

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation or corporation, which is organized and operated exclusively for charitable. educational or religious and/or scientific purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

The period of existence of this corporation shall be perpetual.

The purpose for which the corporation is formed is to establish, organize, supervise and operate a teaching and training program, and to engage in any other lawful act or activity for which a non-profit corporation may be organized under the Idaho Business Corporation Act.

The location of the registered office of the corporation in the State of Idaho is 27791 N. Clearwater, Athol, ID 83801. The Post Office address is P O Box 1744, Hayden, Idaho 83835. This non-profit corporation is a non-member corporation.

This non-profit corporation shall have all the powers granted to general business corporations under the laws of the State of Idaho.
