expressed.

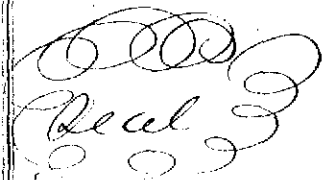
Article 1. The corporate name
