ARTICLES OF INCORPORATION

of

The following Articles of Incorporation are hereby adopted pursuant to the Idaho Business Corporation Act:

1. Name.

The name of the corporation is:

2. Duration.

The corporation shall have perpetual duration.

3. Purposes.

The corporation is formed for the purposes of retail building supply, storage sheds and any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
