# ARTICLES OF INCORPORATION OF

# WEIPPE RODEO ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the duly elected officers and members of WEIPPE SEDRETARY OF STATE
RODEO ASSOCIATION, all of whom are bona fide residents of the
State of Idaho; and which said Weippe Rodeo Association is an
organization or society associated and handed together for benevolent, social, recreational, and civic purposes, and not in any
manner for profit; and after due notice having been given; have
voluntarily associated ourselves together, and do hereby voluntarily associate ourselves together, and under the terms and
provisions of Chapter 3, Title 30, Idaho Code, set forth Articles
of incorporation as follows, to-wit;

#### ARTICLE I

The name of this corporation shall be; WEIPPE RODEO ASSOCI-

#### ARTICLE II

The periol of existance and duration of like of this corporation shall be perpetual.

### Adlich III

The pupose for which this corporation is formed are as follows, to-wit:

- (1) To advance the general community intrest; to provide recreational facilities for the members of the corporation; to provide entertainment for the citizens of the area; to promote public intrest in rodeos and horsemanship in the community; to promote safety and cooperation among riders and participants in rodeos; and to provide, foster, and promote civic advancement to the community.
- (2) To lease, purchase, hold, have, use, and take possession of and enjoy any personal and real property necessary for the uses and purposes of the corporation; and to sell, lease, alien

or dispose of the same at the pleasure of the corporation, for the uses and purposes for which the said corporation is formed; and to buy and sell real and personal property, and to apply the proceeds of sale, including any and all income, to the uses and purposes of the corporation.

(3) This corporation is one which does not contemplate peruniary gain or profit to the members thereof.

# ARTICLE IV

The registered office and agent of the corporation is MARY ANN CHARMAN, POC 262, WEIPPE, IDAHO 83553.

#### ARTICLE F

The business of the corporation shall be carried on and conducted by a Board of Directors consisting of seven (7) members, and shall include the President, the Vice President, the Secretary, Treasurer, and three (3) Directors.

The President, Vice President, the Secretary, Treaturer and Three Directors, shall be elected from the membership of MUTOPF RODEO ASSOCIATION, INC., at the regular meeting hold the second Friday of April each and every year. They shall be elected for a two year term.

A membership in Weippe Rodeo Association, Inc., shall and does constitute one (1) share in the corporation, and such share does and shall carry one (1) vote at any and all corporate meeting. The roster of members in good standing of the corporation at all times shall be and in the official register of shares therein.
