As certified by the Secretary of the corporation, the Shareholders and Directors of TRUE NORTH, INC., a Colorado corporation, do hereby unanimously approve, consent to and ratify the following actions and decisions of the corporation in lieu of a special meeting:

- 1. BE IT RESOLVED that the corporation is expanding its existing business, which is the retail sale of women's clothing and furnishings to a third location in Ketchum, Idaho. This is due to Ketchum's ski resort location, which is consistent with the type of lines carried and the locations of the corporation's other retail outlets.
- 2. BE IT FURTHER RESOLVED that as a result of the decision to expand to Ketchum, Idaho, the corporation has entered into a lease of real property for retail space in the 511 Building, which is located at Suite 201, 511 Leadville Avenue North in Ketchum, Idaho, which is suitable for the corporation's needs.
- 3. BE IT FURTHER RESOLVED that since the corporation desires to conduct this business in Idaho, it is required by law to qualify to do business in Idaho by registering as a foreign corporation and receiving a Certificate of Authority from the Secretary of the State of Idaho, and therefore, has directed its President, Judith Ryan to take all steps necessary to accomplish this. In pursuit of such end, Ms. Ryan has hired John A. Seiller, licensed attorney at law in Idaho, who will prepare the necessary documents to gain such authority.
- 4. BE IT FURTHER RESOLVED that the corporation has been forced by Idaho law to register under a fictitious name and has chosen TN3. This is an abbreviation for the corporation's third retail outlet. The corporate name TRUE NORTH, INC. is already being used by an existing Idaho corporation completely unrelated to this corporation. The Idaho

corporation performs surveying work in north Idaho. There is goodwill associated with the corporate name True North through the Colorado corporation's other retail outlets. As a result, the corporation would like to use that name in association with the Ketchum, Idaho retail outlet, including, but not limited to using such name on the signage and advertising. Therefore, we hereby direct Ms. Ryan to take all steps necessary for the fictitiously named entity TN3 to file with the Secretary of the State of Idaho for an Assumed Business Name to do business as and use the name True North.
