FIRST

SECOND

The purposes of the corporation are as follows:

To engage in the practice of law through duly licensed attorneys at law in the State of Idaho and in any other state in which this professional corporation qualifies to do business through duly license attorneys.

To invest in real estate, mortgages, stocks, bonds or any other type of investment. To own real or personal property necessary for rendering professional services.

THIRD

The duration of this corporation shall be perpetual.

FOURTH

This corporation shall operate in full compliance with the Professional Service Corporation Act of the State of Idaho and the applicable rules of professional conduct for attorneys. No one shall be permitted to own stock in the corporation unless he or she is properly licensed to practice law. No one may be an officer of the corporation unless he or she is duly licensed to practice law, except that a non-lawyer shall be secretary of the corporation if the corporation has only one shareholder.

FIFTH

The location of the registered office of the corporation in the State of Idaho is 1426 Oakley Avenue, Burley, Idaho 83318. The name of the registered agent for the corporation at the registered office is A. Elizabeth Burr-Jones.

SIXTH

The total authorized number of shares is 1,000 having no par value. The stock of the corporation is of but

one class: Common. Shares are nonassessable by or on behalf of the corporation.

The name and post office address of the incorporator, and the number of shares of stock subscribed are as follows:

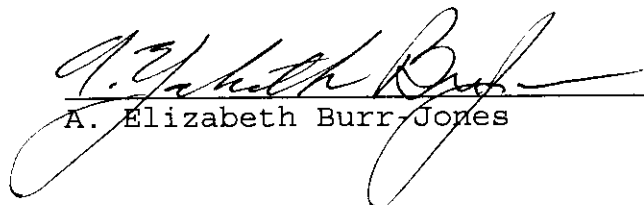

The power to repeal and amend bylaws and adopt new bylaws shall rest with the shareholders by a majority vote of the shareholders.

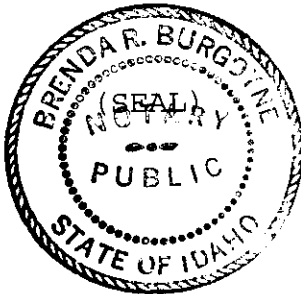
