Section 1. This association shall be known as the NORTHWEST INTERSTATE QUARTER HORSE ASSOCIATION, INC and shall at all times be operated and conducted as a non-profit association in accordance with the laws of the State of Idaho.

Section 2. The purpose of this Association shall be to:  
(a) Improve and promote the American Quarter Horse Breed.  
(b) To promote , support and encourage on e another as we improve the Quarter Horse Breed.  
(c) To have horse Shows, Clinics, Rodeos, Seminars & etc.

Section 3. To never cease holding monthly meetings. If the Association votes to abolish, funds will be forwarded to the closest Quarter Horse Association, or AQHA. This will be done with respect to the laws regarding the distribution of asset on dissolution in the State of Idaho.
