ARTICLES OF INCORPORATION

FOR

RAPID RIVER GENERAL STORE, INC.

1. The name of the Corporation is **RAPID RIVER GENERAL STORE, INC.**

2. The Incorporators of the Corporation are **Wilbert K. Windish and Ada Marie Windish**

3. The Corporation is organized as a domestic profit corporation pursuant to the provisions of the Idaho Corporation Code as amended.

4. The Corporation shall have perpetual duration.

5. The Corporation is organized for the purposes of operating as a convenience store and to engage in any other lawful act or activities for which a Corporation may be organized under the laws of Idaho.

6. The Corporation shall have the authority to issue not more than 1,000 Shares of common stock with a par value of \$1.00.

7. The initial registered office shall be **HC 69 Box 400, Riggins, Idaho 83549**. The initial registered agent of the Corporation at that address shall be **Wilbert K. Windish** who by signing these articles as an incorporator agrees to serve as registered agent.

8. The mailing address of the principal office shall be the convenience store known as **Rapid River General Store, Inc, HC 69 Box 400, Riggins, Idaho**. The incorporators shall be **Wilbert K. Windish and his wife Ada Marie Windish** whose address shall be **HC 69 Box 400, Riggins, Idaho**.

9. The directors shall be **Wilbert K. Windish and Ada Marie Windish** whose address after March 1, 1992 shall be **HC 69, Box 400 Riggins, Idaho** The directors shall have the limitation of personal liability as defined by statutes and the Model Business Code.
