KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, each of whom is a natural person of adult age and a citizen of the United States of America, desiring to form a corporation under the laws of the State of Idaho, do hereby adopt these Articles of Incorporation and execute the same in duplicate; as follows:

ARTICLE I

The name of the corporation is: "Northwest Bounty, Inc."

ARTICLE II

The duration of the corporation shall be perpetual.

ARTICLE III

The registered office of the corporation in this state shall be at 112 W. Fourth St., P. O. Box 9632, Moscow, Idaho 83843. The name of the registered agent at that address is Ivar Nelson.

ARTICLE IV

The purpose of the corporation shall be to promote and sell regionally produced and manufactured food products and engage in any other lawful activity for the benefit of shareholders

ARTICLE V

The corporation is authorized to issue a total of five hundred (500) shares of stock, all of which shall be common stock, all of one class, with no par value.

ARTICLE VI

The internal affairs of the corporation shall be governed by Bylaws to be adopted by vote of the shareholders.

ARTICLE VII

Transfer of shares shall be restricted by a requirement that before any shares can be transferred they must first be offered for sale to the corporation and other shareholders, as more fully set forth in the Bylaws.

ARTICLE VIII

The number of directors of the corporation shall be as specified in the Bylaws, as they may be adopted and amended from time to time. The initial Board of Directors shall consist of 2 directors, whose names and addresses are set forth below and who shall serve until their successors are elected at a duly constituted meeting of shareholders:


