These Articles of Amendment and the following certificate are hereby made and executed pursuant to Section 30-327, Idaho Code, for the purpose of amending the Articles of Incorporation and to change the stock of this corporation to no par value.

The undersigned, John L. Ellsworth, Lewis Maupin and Joseph Merrick, being all of the directors of the corporation, do hereby respectively certify as follows:

I

That a meeting of all of the directors of Castle Creek
Irrigation Company, an Idaho corporation, was held on November
10, 1980, at 1522 West Idaho Street, Boise, Idaho, pursuant to
Call and Waiver of Notice signed by all of said directors and
filed in the Minute Book of the corporation.

II

There are no members of this corporation.

III

That at such meeting, the following resolutions were presented, and upon motion duly made, seconded and unanimously carried, the same were adopted:

BE IT RESOLVED, That the Articles of Incorporation of Castle Creek Irrigation Company be amended to change the stock of this corporation to no par value stock, and to increase said stock to 4,000 shares.

BE IT FURTHER RESOLVED, That paragraph VI of said Articles of Incorporation be amended to read as follows:

"VI

The total amount of the authorized capital stock of this corporation is 4,000 shares having no par value."

BE IT FURTHER RESOLVED, That paragraph VII of said Articles of Incorporation be amended to read as follows:

"VII

Any person owning agricultural property within the area serviced by the corporation shall be entitled to the receipt of one share of stock per acre of property serviced by the corporation, and said person shall be required to pay his proportionate share of corporate expense incurred to deliver water to the parcel of property represented by the share he holds, as well as any expenses for expansion of the system to provide service to the property."

BE IT FURTHER RESOLVED, That paragraph X of said Articles of Incorporation be amended to read as follows:

"X

This corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute, and all rights conferred upon stockholders herein are granted, subject to this reservation."
