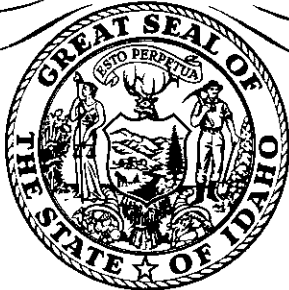

I FURTHER CERTIFY, That the persons executing the articles and their associates and  
successors are hereby constituted a corporation, by the name hereinbefore stated, for  
**perpetual existence** from the date hereof, with its registered office in this State located at  
**Coeur d'Alene** in the County of **Kootenai**  
and as such are subject to the rights, privileges and limitations granted to Non-Profit Coopera-  
tive Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION  
of  
INLAND EMPIRE TENNESSEE WALKING HORSE BREEDERS  
AND EXHIBITORS ASSOCIATION OF AMERICA, INCORPORATED

We, the undersigned, being natural persons of legal age and citizens of these United States do hereby voluntarily associate ourselves for the purposes of forming a corporation under and pursuant to the provisions of Chapter 10, Title 30, Idaho Code, pursuant to the laws of the State of Idaho, and do hereby set forth and certify as follows:

I.

The name of this corporation shall be THE INLAND EMPIRE TENNESSEE WALKING HORSE BREEDERS AND EXHIBITORS ASSOCIATION OF AMERICA, INCORPORATED.

II.

The duration of this corporation shall be perpetual.

III.

The location and post office address of the corporation shall be as follows: Inland Empire Tennessee Walking Horse Breeders and Exhibitors Association of America, Incorporated, 501 Northwest Boulevard, Coeur-d'Alene, Kootenai County, Idaho.

IV.

The affairs and management of said corporation are to be under the control of a Board of Directors consisting of at least five (5) directors and such officers as shall be elected therefrom, whose qualification and

election shall be fixed and prescribed by the By-Laws of said corporation as provided by 30-1005, Idaho Code.

V.

The nature of the business to be transacted and the purposes to be promoted and carried out by this corporation are for the attraction of interest of persons and individuals in the owning, training, breeding, purchasing and acquiring of Tennessee Walking Horses for show and for pleasure.

VI.

That the rights and interest of all members in said corporation shall be equal and no member can have or acquire any greater interest therein than any other member, and such membership shall not be transferrable. The corporation shall not issue any capital stock but shall issue membership certificates upon the terms, conditions and qualifications as shall be fixed by the By-Laws.

VII.
