Articles of Incorporation

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned natural persons of lawful age and citizens of the United States of America, for the purpose of forming a corporation pursuant to the provisions of the Idaho Business Corporation Act (Title 30, Idaho Code) do hereby certify as follows:

FIRST: The Name of the corporation is Hidden Hills Inc., hereinafter called the corporation.

SECOND: The corporation is to have perpetual existence.

THIRD: The purpose and objects for which the corporation is organized include the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act (Title 30, Idaho Code).

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000). Such shares are to consist of one class only. Such shares shall have no par value and once issued shall be non-assessable.

FIFTH: All shares of stock issued shall be common stock, and all shares shall have equal value, without preferences, limitations or differences in relative rights with respect to other shares.

SIXTH: Stockholders of the corporation shall have pre-emptive and preferential rights of subscription to any shares of stock of the corporation, whether now or hereafter authorized, or to any obligations convertible into stock of the corporation, or to obligations of the corporation convertible into stock. Any stock or obligations issued by the corporation shall first be offered to the stockholders of the corporation.
