Notice is hereby given that the Articles of Incorporation of NU-TECH AGRICULTURE, INC. are hereby filed with the Secretary of State of the State of Idaho.

#### ARTICLE I

The name of the corporation shall be: NU-TECH AGRICULTURE, INC.

# ARTICLE II

The period of the duration of the corporation shall be perpetual.
