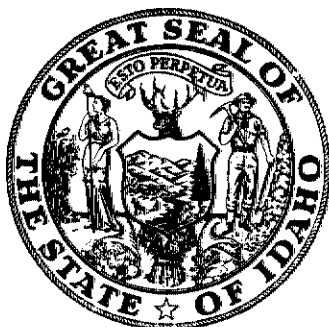

ARTICLES OF INCORPORATION
OF
ASSURANCES, INC.

The undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: That the corporation's name is Assurances, Inc.

SECOND: That the period of its duration is perpetual.

THIRD: That the corporation is organized for the purpose of transacting any and/or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including but not limited to private investigation and security consultation services.

FOURTH: That the corporation shall have authority to issue an aggregate number of shares of one thousand (1,000), all of one class, without par value and with full preemptive rights under the Idaho Business Corporation Act.

FIFTH: That the address of the corporation's initial registered office is 1066 Claredot, Idaho Falls, Idaho 83402, and the name of its initial registered agent at such address is Orville Lawrence Jones.

SIXTH: That the corporation's shareholders may, from time to time, distribute to themselves out of the corporation's capital surplus a portion of its assets, in cash or property, subject to the following provisions:

(a) No such distribution shall be made at a time when the corporation is insolvent or when such distribution would render the corporation insolvent.

(b) No such distribution shall be made unless it is authorized by the affirmative vote of the holders of a majority of the outstanding shares.

(c) Each such distribution, when made, shall be identified as a distribution from capital surplus and the amount per share disclosed to the stockholder receiving the same concurrently with the distribution thereof.

SEVENTH: That the number of directors constituting the corporation's initial Board of Directors is two (2), with a maximum of six (6) thereafter, and the name and address of the person who is to serve as the Director until the first annual meeting of the stockholders or until his successor is elected and shall qualify is:


