The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is NORTHWEST FORESTS, INC.

SECOND: The period of its duration is perpetual.

THIRD:

The purpose or purposes for which the corporation is organized are: To engage in the tree planting and other related forest enterprises and activities allowed by Idaho law and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
