The net profits of the partnership shall be divided as follows: Eighty percent (80%) is divided among general partners in proportion to their partnership units and twenty percent (20%) is divided among limited partners in proportion to their partnership units. 8. There is no agreement concerning the making of additional contributions by any limited partner, nor is there any agreement concerning the time when the contribution of any limited partner is to be returned. A limited partner may substitute his spouse, children, issue, siblings, or any member of his family, or a trust, corporation, or legal entity created primarily for the benefit of such persons, without the consent or approval of the partners. Any other substitution of a limited partner requires the consent of a majority of the general partners. 10. Additional limited partners may be admitted only upon the consent of a majority of the general partners. There are no priorities between the limited partners as to contributions or as to compensation by way of income. In the evert of the death or retirement of any general or limited partner, the partnership shall be dissolved, but the remaining partners shall have the right to continue the partnership business by purchasing the deceased or retiring partner's interest in the partnership at a value to be determined by appraisal to be made by three appraisers, or by reconstituting general partnership interest as limited partnership interests.
