1 ARTICLES OF INCORPORATION

3 SECTION 1. THE CORPORATE POWERS TO CONDUCT THE BUSINESS
4 AND MANAGE THE PROPERTY OF THIS CORPORATION SHALL BE
5 VESTED IN AND EXERCISED AND CONTROLLED BY A BOARD OF
6 DIRECTORS, NONE OF THEM NEED BE SHAREHOLDERS. THE BOARD
7 OF DIRECTORS SHALL BE NOT LESS THAN TWO NOR MORE THAN
8 FIVE IN NUMBER. TO BE DETERMINED BY THE OFFICERS FROM
9 TIME TO TIME.

11 ARTICLE II

12 OFFICERS

13 SECTION 1. THE OFFICERS OF THIS CORPORATION SHALL
14 CONSIST OF A PRESIDENT, AND ONE OR MORE VICE PRESIDENTS,
15 A SECRETARY, AND A TREASURER FROM TIME TO TIME, IF THE
16 OFFICERS SO DESIRE. ANY TWO OF THE ABOVE OFFICES, EXCEPT
17 THE OFFICE OF PRESIDENT, MAY BE COMBINED IN ONE PERSON.

18 SECTION 2. THE PRESIDENT AND AT LEAST ONE VICE
19 PRESIDENT SHALL BE DIRECTORS OF THE CORPORATION.

20 SECTION 3. THE AMOUNT OF SALARY WHICH EACH OF THE SAID
21 OFFICERS SHALL RECEIVE AND THE MANNER AND TIMES OF ITS
22 PAYMENT SHALL BE FIXED AND DETERMINED BY THE OFFICERS OF
23 THE CORPORATION. IT MAY BE ALTERED BY SAID OFFICERS FROM
24 TIME TO TIME AT ITS DISCRETION.

26 ARTICLE III

27 POWERS AND DUTIES OF OFFICERS

28 THE OFFICERS SHALL HAVE THE POWER:
29 FIRST TO REMOVE ANYAT PLEASURE ANY OR ALL AGENTS, AND
30 EMPLOYEES OF THE CORPORATION, PRESCRIBE SUCH DUTIES FOR
31 THEM AS MAY NOT BE INCONSISTENT WITH THESE BY-LAWS AND
32 THE LAWS OF THE STATE OF IDAHO; FIX THEIR COMPENSATION

1 AND ALTER THE SAME FROM TIME TO TIME, AND IF DEEMED
2 ADVISABLE TO REQUIRE A GOOD AND SUFFICIENT CORPORATE
3 SURETY BOND FOR THE FAITHFUL PERFORMANCE OF THEIR DUTIES.
4 SECOND- TO EXERCISE, CONDUCT, MANAGE AND CONTROL THE
5 POWERS, BUSINESS, AFFAIRS AND PROPERTY OF THE
6 CORPORATION, AND TO MAKE SUCH RULES AND REGULATIONS
7 THEREFORE NOT INCONSISTENT WITH THESE BY-LAWS AND THE
8 LAWS OF THE STATE OF IDAHO AS THEY DEEM BEST.
9 THIRD- TO FIX FROM TIME TO TIME THE PLACE OF THE OFFICE OF
10 THE CORPORATION AND TO AUTHORIZE OFFICES FOR SUCH
11 CORPORATION AT OTHER PLACES WITHIN OR WITHOUT THE STATE
12 OF IDAHO AND TO ADOPT, MAKE AND USE A CORPORATE SEAL AND
13 TO PRESCRIBE THE FORMS AND TO ALTER SUCH FORMS OR SEAL
14 FROM TIME TO TIME AS IN THEIR JUDGMENT MAY SEEM PROPER.
15 FOURTH- TO DECLARE DIVIDENDS OUT OF THE SURPLUS PROFITS
16 OF THE CORPORATION IN ANY MANNER NOT INCONSISTENT WITH
17 THE LAWS OF THE STATE OF IDAHO. AT A TIME AND
18 PLACE OF THEIR CHOICE
19 FIFTH- THE OFFICERS SHALL MEET EVERY 30 DAYS TO SEE TO THE
20 AFFAIRS OF THE CORPORATION.

22 ARTICLE IV

23 THE STOCK OF THE CORPORATION SHALL BE OF NO PAR VALUE.

24 ARTICLE V

25 THE PURPOSE OF THE CORPORATION IS TO TRANSACT ANY AND ALL
26 BUSINESS THAT IS NOT FORBIDDEN BY LAW.

27 ARTICLE VI

28 THE PRESIDENT SHALL HAVE GENERAL CHARGE OF AND CONTROL
29 OVER THE AFFAIRS OF THE CORPORATION.

THE MEETINGS OF THE OFFICERS MAY BE WITHIN OR WITHOUT THE STATE OF IDAHO OR ANY OTHER PLACE THE OFFICERS MAY DEEM.

ARTICLE VIII

ALL CHECKS OR DEMANDS FOR MONEY AND NOTES OF THE CORPORATION SHALL BE SIGNED BY AN OFFICER OF THE CORPORATION.
