1 ARTICLES OF INCORPORATION OF
2 CAMAS PLANT BREEDING INSTITUTE, INC.

3 KNOW ALL BY THESE PRESENTS:

4 That we, the undersigned, being all of lawful age, citi-
5 zens of the United States of America, do, under and in pursuance of
6 the general corporation laws of the State of Idaho, and particularly
7 Section 30-301, et seq., Idaho Code, hereby organize, constitute and
8 associate ourselves and such other persons as may hereafter become
9 associated with us, for the purpose of forming a non-profit corpora-
10 tion under the laws of the State of Idaho, and we do hereby adopt
11 and certify the following ARTICLES OF INCORPORATION, and we hereby
12 set forth and declare as follows:

13 ARTICLE I.

14 That the name of this corporation shall be CAMAS PLANT
15 BREEDING INSTITUTE, INC.

16 ARTICLE II.

17 That the location and post office address of the regis-
18 tered office in the State of Idaho for the transaction of business
19 of this corporation shall be 1204 East F Street, Moscow, Idaho 83843,
20 and the name of the registered agent at such address is Warren K.
21 Pope.

22 ARTICLE III.

23 That the duration and term of the existence of this cor-
24 poration shall be perpetual.

25 ARTICLE IV.

26 That in furtherance, and not in limitation of the general
27 powers conferred by the laws of the State of Idaho, this corpora-
28 tion shall have the following objectives, purposes and powers:

29 (A) To promote the general welfare of agriculture
30 through the genetic improvement of agricultural crops; to provide
31 a mechanism for the increase and distribution of these improved

1 plant types; to maintain a permanent seed and plant collection for
2 the preservation of plant breeding stocks and their further distri-
3 bution to national seed storage centers; to produce, maintain and
4 distribute genetically segregating plant populations, useful in
5 plant breeding and plant genetic studies; to provide a center for
6 the general promotion of plant breeding studies and plant genetic
7 studies.

8 (B) To procure, accept and administer grants, donations
9 and/or loans from any public or private source for the above pur-
10 poses; provided that the private property of the officers, directors
11 and stockholders of the corporation shall be exempt from the debts
12 of the corporation, and no officer, director or stockholder shall
13 be jointly or severally liable or responsible for any debts or lia-
14 bility of the corporation on account of such status or conduct inci-
15 dental to or required by such office, role or status.

16 (C) To generally engage in, do and perform, any enter-
17 prise, act, or vocation that a natural person might or could do or
18 perform; so long as in conformance with the other purposes herein
19 enumerated.

20 (D) To engage in the business of buying, acquiring, giv-
21 ing, owning, leasing, transferring, encumbering, and generally deal-
22 ing in real and personal property so long as in conformance with
23 the other purposes herein enumerated.

24 (E) To borrow money for the use of said corporation and
25 to issue securities therefor and to pledge, mortgage, hypothecate
26 and otherwise dispose of the real, personal and intangible property
27 of the corporation as security therefor.

28 This corporation shall never carry on any business, trade,
29 avocation or profession for profit.

30 To do all things in connection with its objectives per-
31 mitted by law and to exercise any and all powers not prohibited by
32 law as pertains to organizations of this type.

ARTICLE V.

This corporation is not organized for profit and shall have no capital stock, and shall be composed of members with equal voting power rather than shareholders in accordance with the foregoing provisions.

The rights of all members of this corporation shall be equal, and no member shall have or acquire a greater interest therein than any other member.

ARTICLE VI.

The conditions and regulations of membership and the rights and privileges shall be determined and fixed by the By-Laws.

ARTICLE VII.

The affairs of this corporation shall be conducted by a Board of Directors of at least three in number, with the exact number, manner of selection and qualifications as determined by the By-Laws. The Board of Directors may appoint an Executive Committee which shall possess and may exercise the powers of the Board of Directors in the management and direction of the affairs of the corporation during the intervals between meetings of the Board of Directors.

ARTICLE VIII.

The private property of the members shall not be subject to the payment of corporate debts, liabilities or obligations to any extent whatsoever.

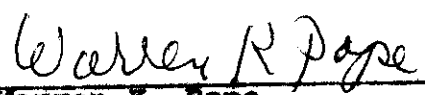
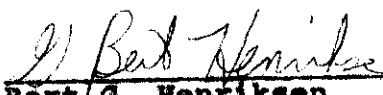
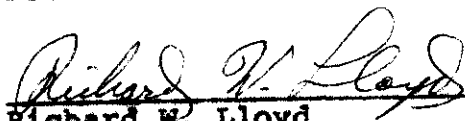
