ARTICLES OF AMENDMENT

APR 20 1933

HECLA MINING COMPANY, A WASHINGTON CORPORATION SECRETARY OF STATE.

CORPORATION SECRE

IT IS HEREBY CERTIFIED by the undersigned, the President and Secretary, respectively, of the HECIA MINING COMPANY, a corporation, that at the Annual Meeting of Shareholders of Hecla Mining Company, held at the Ballroom of the Ridpath Hotel, Spokane, Washington, on the 25th day of April, 1968, pursuant to proper notice, the following amendment to the Articles of Incorporation was adopted by the necessary two-thirds vote of all outstanding shares of the corporation entitled to vote upon such amendment, as is more particularly set forth in paragraph 6 below.

- 1. The name of the corporation is HECLA MINING COMPANY.
- 2. The amendment so adopted is as follows:

Section 1 of Article VI of the Restated Articles of Incorporation of Hecla Mining Company is amended to read as follows:

"ARTICLE VI.

"Section 1. The capital stock of this Corporation shall be One Million Five Hundred Thousand Dollars (\$1,500,000.00), divided into Six Million (6,000,000) shares at a par value of Twenty-five Cents (25¢) per share."

- 3. The foregoing amendment was adopted on April 25, 1968.
- 4. All outstanding shares of Hecla Mining Company are of one class. The number of shares outstanding as of the record date, the 28th day of March, 1968, were 2,475,054 shares, including 115 treasury shares, and the number of shares entitled to vote were 2,474,939 shares represented in person or by proxy.
- 5. The number of shares voting for and against said amendment are as follows:

6. The Amendment effects an increase in the capitalization of Hecla Mining Company from 2,750,000 shares of the par value of 25ϕ per share, or \$687,500.00, to 6,000,000 shares of the par value of 25ϕ per share, or \$1,500,000.00. Pursuant to resolution adopted by the Board of Directors on April 25, 1968, \$618,763.50 has been transferred from the capital surplus account to the stated capital account to reflect this amendment of the stated capital.
