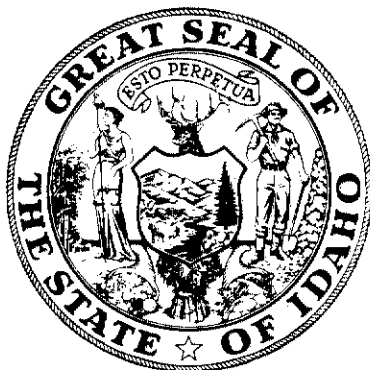

ARTICLES OF AMENDMENT

OF

PURSUANT to Section 30-326, Idaho Code, and Article Eleventh of the Articles of Incorporation of The Southern Idaho Corporation of Seventh-Day Adventists, an Idaho non-profit corporation, upon due statutory notice thereof, at its regular annual meeting in Caldwell, Idaho, held on the 18th day of May, 1986, the Board of Trustees of The Southern Idaho Corporation of Seventh-Day Adventists, because Board of Trustees constitutes the membership of said corporation, did adopt the following resolution:

RESOLVED, that paragraph (k) of Article Second of the Articles of Incorporation of The Southern Idaho Corporation of Seventh-Day Adventists be changed to paragraph (l) and the paragraph set forth below be added as paragraph (k) of Section Second:

"(k) To act as a trustee of a trust involving the property or estate of any person; to act as the personal representative of the estate of any person; to provide such services without fee and to take all such actions as may be necessary or incident thereto; and"

The date of adoption of said amendment is May 18, 1986. The meeting at which the foregoing Resolution was adopted was attended by a majority of the members of the Board of Trustees of The Southern Idaho Corporation of Seventh-Day Adventists, and the foregoing Resolution was adopted by a unanimous vote of the Board members attending such meeting, and such vote represented more than a majority vote of the Board members then in office.
