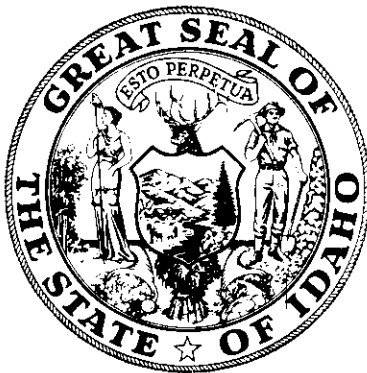

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is VEIGEL & ASSOCIATES, P.A.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on the 2nd day of January, 1991, in the manner prescribed by the Idaho Business Corporation Act:

The name of the corporation was changed from VEIGEL & ASSOCIATES, P.A., to SCHILLER & FLORENCE, CHARTERED.

The address of the registered office was changed from 805 West Idaho, Boise, Idaho, to 200 North 4th Street, Suite 200, Boise, Idaho, 83702.

The name of the registered agent was changed from Carleton G. Veigel, to JEFFREY J. SCHILLER.
