ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION ~~3 12 PM '91~~

Pursuant to the provisions of Sections 30-1-59 and 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of the corporation is SILVER CREEK, INC.

SECOND: At the annual meeting held on February 11, 1991, shareholders of the corporation adopted and approved the following amendment to the Articles of Incorporation of Silver Creek, Inc., pursuant to which the existing Article V is deleted and a new Article V is added to the original Articles of Incorporation of Silver Creek, Inc. as filed on January 12, 1984:

"V.

The aggregate number of shares which the corporation shall have authority to issue is 1,000,000 shares of common stock with a par value of \$1 per share."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 152,597; and the number of shares entitled to vote thereon was 152,597.

FOURTH: The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:

FIFTH: The number of shares voted for such amendment was 111,665; and the number of shares voted against such amendment was 0.
