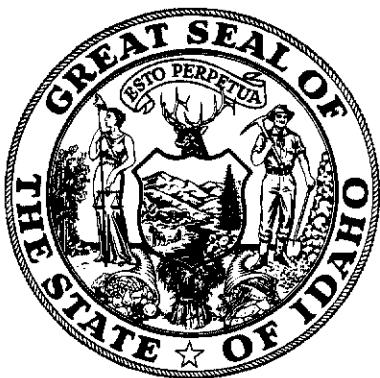
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION  
OF

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, being a natural person of full age and citizen of the United States, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

ARTICLE I

The name of the corporation is J. OLIVER & COMPANY, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The corporation is organized for the purpose of conducting and transacting any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares and shall have no par value.

ARTICLE V

Provisions for the regulation of the internal affairs of the corporation are as shall be set forth in the Bylaws of the corporation as from time to time be adopted or amended.

ARTICLE VI
