# 35 JUN BROWALHMEN BY THESE PRESENTS:

That I, the undersigned, being of full age and a citizen of the United States, do this day volumently for corporation under the provisions of the Idaho Business Corporation Act, and I certify in writing:

#### 1. NAME

The name of the corporation shall be On Stage, Inc.

## 2. PURPOSE AND POWERS

The purposes for which this corporation is formed are to own and operate retail businesses selling dance and active wear, to license the use of the tradmark/tradename On Stage<sup>TM</sup>, to offer advice and counsel about the conduct of the business of selling dance and active wear, and to engage in any lawful act or activity for which corporations may be organized under the Idaho Business Corporation Act and to possess and exercise all the powers and privileges granted by the Idaho Business Corporation Act or any lawful powers and privileges incidental thereto, so far as such powers and privileges are necessary or convenient to the conduct, promotion or attainment of the business or purposes of the corporation.

#### 3. DURATION

Subject to dissolution in the manner provided by law, the corporation shall be perpetual.

#### 4. **REGISTERED OFFICE**

The registered office of the corporation in the State of Idaho shall be located at 7091 Overland Road, Boise, Idaho 83709. The mailing address of the registered office of the corporation in the State of Idaho, County of Ada, shall be 7091 Overland Road, Boise, Idaho 83709. Julie Splan shall be the registered agent at the address set forth above.

#### 5. CORPORATE STOCK

The aggregate number of common shares which the corporation shall have authority to issue is 10,000, all of which shall have a no par value.

#### 7. MANAGEMENT

The business of the corporation shall be managed by a board of at least 3 directors, except that if all of the shares of the corporation are owned beneficially and of record by either 1 or 2 stockholders, the number of directors may be less than 3 but not less than the number of stockholders. A director shall hold office for the term for which he/she was named or elected and until his/her successor is elected and qualified. The incorporator listed in Article 6 above shall serve as the sole director until the first annual meeting of shareholders or until her successor is elected and qualified.

#### 8. BY-LAWS

The initial By-Laws of the corporation shall be adopted by its board of directors. The power to alter, amend or repeal the By-Laws or adopt new By-Laws, subject to repeal or change by action of the shareholders, shall be vested in the board of directors.
