# ARTICLES OF INCORPORATION OF GLOBAL INTERNATIONAL DEVELOPMENT, INC.

The undersigned, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation.

#### **FIRST**

The name of the corporation is GLOBAL INTERNATIONAL DEVELOPMENT, INC. and its existence shall be perpetual.

#### **SECOND**

The corporation is formed and organized to engage in the business of initiating and operating development projects, and to engage in any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act and as the Board of Directors may from time to time determine.

#### **THIRD**

The aggregate number of shares which the corporation has the authority to issue is Five Million (5,000,000) shares of common stock, all of one class, at a par value of \$1.00 each.

The corporate stock of this corporation shall be non-assessable, and the private property of the shareholders and each of them, of this corporation shall not be subject to assessment or be liable for the debts, obligations or liabilities of this corporation.

#### **FOURTH**

The number of directors of the corporation shall be as specified in the bylaws, and such number may from time to time be increased or decreased in such manner as may be prescribed in the bylaws, provided the number of directors of the corporation shall not be fewer than the number required by law. The initial Board of Directors shall number four (4). In case of any increase in the number of directors, the additional directors may be elected by the directors then in office, and the directors

so elected shall hold office until the next annual meeting of the stockholders and until their successors are elected and qualified.

A majority of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum at a meeting of shareholders.

Stockholders of the corporation shall have pre-emptive and preferential rights of subscription to any shares of stock of the corporation, whether nor or hereafter authorized, or to any obligations of the corporation convertible into stock.

The initial bylaws shall be adopted by the Board of Directors. The power to alter, amend or repeal the bylaws or adopt new bylaws, subject to repeal or change by action of the shareholders, shall be vested in the board of directors. Such power may be exercised by a majority vote of the board of directors at any annual or special meeting of the board of directors called for that purpose.

The articles of incorporation of this corporation may be amended by a majority vote at any annual or special meeting of stockholders, either upon consideration of a resolution for amendment adopted by the board of directors or upon consideration of a resolution adopted by the holders of not less than ten percent (10%) of all of the shares entitled to vote at such meeting.

#### FIFTH

The location and post office address of the initial registered office of the corporation is 3701 Pasadena Drive, Boise, Idaho 83705, and the name of the initial registered agent of the corporation who may be found at that address is Dale C. Creech.
