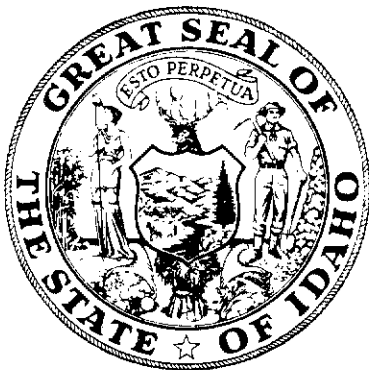

All debts, obligations and liabilities of the Corporation have been paid and discharged, or adequate provision has been made therefor.




