KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, in order to form a corporation, pursuant to the laws of the State of Idaho, do hereby certify as follows:

ARTICLE I

ARTICLE II

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III

This corporation is formed to carry out any lawful purpose and shall have all the powers allowed by the laws of the State of Idaho.

ARTICLE IV

The capital stock of this corporation shall be in the amount of \$25,000.00, divided into 25,000 shares of non-assessable common stock of the par value of \$1.00 per share.

ARTICLE V

The principal place of business of this corporation shall be in the City of Boise, County of Ada, State of Idaho. The registered office of the corporation shall be in care of Howard E. King, 4980 Wildrye, Boise, Idaho 83703.

The management of this corporation shall be vested in a board of not less than one (1) director and a maximum number as may be fixed by the By-Laws.
