CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION

- OF -

HECLA MINING COMPANY.

This certifies that at the regular annual meeting of the stockholders of the Hecla Mining Company, a corporation organized under the laws of the State of Washington, held at its office, Room 507 Empire State Building, in the City of Spokane, State of Washington, on the 11th day of April, 1922, at the hour of 10:00 o'clock A.M., called pursuant to notice as required under its By-Laws, there were represented in person and by proxy 895,012 shares of its capital stock; that the total capitalization of said Company is 1,000,000 shares; that at said meeting a resolution was offered and adopted by a vote of more than two-thirds of all the capital stock of said Company, to-wit: 768,012 shares, amending Article II of the Articles of Incorporation of said Company to read as follows:

"ARTICLE II.

THE PURPOSES for which said corporation is formed are to work, operate, buy, sell, lease, locate, acquire, procure, hold and deal in mines, metals and mineral claims of every kind and description, within the United States of America; to carry on and conduct a general mining, smelting, milling and reduction business; to purchase, acquire, hold, erect and operate concentrating mills, electric light and power plants for the purpose of mining and treating ores and for the purpose of furnishing lights and creating power for all purposes; to bond, buy, lease, locate and hold ditches, flumes and water rights; to construct, lease, buy, sell, build or operate railroads, ferris, tramways, or other means of transportation, for transporting ore, mining and other materials; to own, bond, buy, sell, lease and locate timber and timber claims; to hold, subscribe for, pur-

chase or otherwise acquire, to sell, assign, transfer, mortgage, pledge or otherwise dispose of shares of the capital stock or bonds, debentures, or other evidences of indebtedness of other corporations, and while the holder thereof to exercise all the rights and privileges of ownership, including the right to vote such stock; and finally, to do everything consistent, proper and requisite for the carrying out of the objects and purposes aforesaid, in their fullest and broadest sense, within the territory aforesaid."

That at the regular annual meeting of the Board of Trustees of said Company, held immediately after the adjournment of said stockholders' meeting, at which meeting of the Board of Trustees six ^{of} its seven members were present, a resolution was offered and unanimously adopted amending said Article II of the Articles of Incorporation of said Company so as to read as hereinbefore set out in this Certificate.



