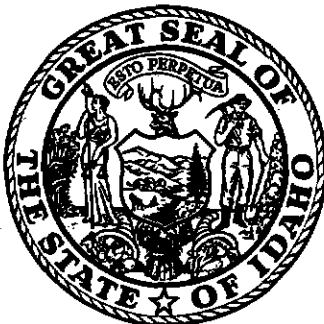

Re: Application for Authority – Silicon Valley Bank

Dear Ms. Loo:

The Idaho Department of Finance (Department) has received and reviewed your letter and its attachments dated June 16, 2011 requesting approval of the corporate name "Silicon Valley Bank, Inc." for use in the state of Idaho.

We understand that Silicon Valley Bank is a California state-chartered bank incorporated in that state. From the information provided in your letter, we understand that Silicon Valley Bank recently hired an Idaho resident as an employee to develop its cash management and payment products. We further understand that Silicon Valley Bank does not intend to open branches in the state of Idaho, but wishes to register in Idaho so that it may obtain the necessary payroll tax identification accounts. In addition, we understand that the Idaho-resident employee will not take deposits or make loans on behalf of Silicon Valley Bank in the state of Idaho.

Section 26-1202 of the Idaho Bank Act prohibits any person, other than a national bank, not authorized to operate as a bank under the Act, to advertise or use as part of its company name the word "bank" or "banker" or any other word of similar import. The Idaho Bank Act does not authorize the Director of the Idaho Department of Finance to waive the requirements of the law. Rather, the Department is offering "no objection" to the corporation's use in Idaho of the name "Silicon Valley Bank, Inc." Under the circumstances discussed above, we do not believe the corporation's proposed use of the name "Silicon Valley Bank, Inc." in Idaho is misleading to the public. While the Department does not intend to pursue an action under this statute, it is possible that another agency may do so. However, we believe the likelihood is slight.
