Pursuant to Title 30 of the Idaho Code, the undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

ARTICLE I NAME OF CORPORATION

The name of the Corporation is "Selway Transportation, Inc.".

ARTICLE II DURATION

This Corporation shall have a perpetual existence.

ARTICLE III

The purpose or purposes for which the Corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLES IV

ARTICLES OF INCORPORATION - 1

ARTICLE V STOCKHOLDERS

The stockholders of the corporation shall have the power to include in the bylaws, adopted by a majority of stockholders of the corporation, any regulatory or restrictive provision regarding the proposed sale, transfer, or other disposition of any of the outstanding stock of the corporation by any of its stockholders. Or, in the event of death of any of its stockholders, the manner and form as well as the relevant terms, conditions, and details thereof, shall be determined by the stockholders of the corporation, provided, however, that such regulatory or restrictive provisions shall not effect the rights of third parties without actual notice thereof, unless the existence of such provision shall be plainly written on the certificate evidencing the ownership of such stock.

No stockholder of the corporation may sell or transfer his stock except to another individual who is eligible to be a stockholder of the corporation, and such sale or transfer will be made only after the same shall have been approved at a stockholders' meeting especially called for such purpose.

In any proposed sale or transfer of stock by any stockholder, the corporation shall be given the option of first refusal to purchase such shares at a price that may be fixed therefore by the Board of Directors.

ARTICLE VI INITIAL REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Corporation is 1452 3rd Avenue, Lewiston, Idaho 83501, and the name of its initial registered agent at such address is Jerry Stuart.

ARTICLE VII FISCAL YEAR

The fiscal year of the corporation shall begin on the first day of October, and end on the thirty-first day of September in each year.
