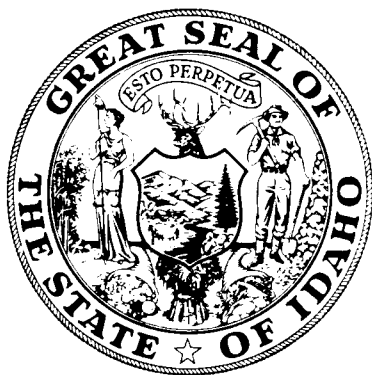

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is GIST AND POWELL AGENCY, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on the 27th day of December, 1982, in the manner prescribed by the Idaho Business Corporation Act:

1. That the name of the corporation be changed from GIST AND POWELL AGENCY, INC. to G P BUSINESS SERVICES, INC.
2. That the registered office of the corporation be changed from PO Box 349, Fruitland, Idaho 83619, to Route 1, Fruitland, Idaho 83619.
3. That the address of the corporation's registered office, as changed, and the address of the business office of its registered agent will be identical.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 150; and the number of shares entitled to vote thereon was 150.

FOURTH: The number of shares voted for such amendment was 150; and the number of shares voted against such amendment was -0-.
