

ARTICLES OF INCORPORATION

of

ASHCRAFT & JORDAN, P.A.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: the name of the corporation is Ashcraft & Jordan, P.A.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which the corporation may be incorporated under the Idaho Professional Service Corporation Act. *Law Firm as per statute*

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 with a par value of \$1.00 per share.

FIFTH: There are no provisions denying preemptive rights.

SIXTH: The address of the initial registered office of the corporation is 430 North Sixth East, Mountain Home, Idaho and the name of its initial registered agent at such address is Larry C. Ashcraft.






