#### ARTICLES OF INCORPORATION

OF

#### SNAKE RIVER BEAN COMPANY

KNOW ALL MEN BY THESE PRESENT, That I, Craig
Hawker a resident of the State of Idaho and a citizen of the
United States and a natural person of full age, have this day
voluntarily associated myself for the purpose of forming
a corporation for profit under the laws of the State of Idaho,
and I do hereby certify and state:

The name of this corporation is: SNAKE RIVER BEAN COMPANY.

II.

Subject to dissolution in the manner provided by law, the corporation shall be perpetual.

III.

Said corporation is formed for the following purposes:

A. To carry on and conduct the general business of buying and selling beans, peas, corn, grain and other agricultural products; to handle and warehouse beans, peas, corn, grain and any and all varieties and kinds of agricultural farm products; to contract with producers for the planting and raising of beans, peas, corn, grain and other farm products and in connection with said contracts to take over in whole or in part the actual planting and raising of such beans, peas, corn, grain and other farm products; to buy, sell, trade and deal in any and all kinds of farm products as broker, factor or agent of others as well as for the account of said

corporation itself; to transport, handle, warehouse, clean, sort, grade or other wise process beans, peas, corn, grain and other agricultural products and commodities.

- B. To lend or advance money or give credit to such person, firms, corporations or associations on such terms as may seem expedient;
- C. To lease, buy, sell, use, mortgage, improve and otherwise handle, deal in, or dispose of all such property, real and personal, as may be necessary or convenient in connection with the aforesaid business of the company.
- D. To carry on other business, or any nature, whatsoever, which may seem to the corporation capable of being conveniently carried on in connection with its business or calculated directly or indirectly to enhance the value of any of the corporation's property or rights or generally to enhance the profitability of the corporation;
- E. If deemed advisable by the corporation, to establish and support or aid in the establishment and support of associations, institutions, funds, trusts, and conveniences calculated to benefit employees or co-employees of the corporation, the stockholders of the company or their heirs, to grant pensions to employees and stockholders, and to make payments toward insurance;
- F. The corporation shall have the power to buy its own stock and to hold the same as treasury stock and to sell and/or otherwise dispose of the same;

- G. To acquire the good will, right, property and assets of all kinds and to undertake the whole or any part of liabilities of any person, firm, association or corporation on such terms and conditions that may be agreed upon; to pay for the same in cash, stocks, bonds, debentures or other securities of this corporation or otherwise; and to acquire and/or take all or any part of the business, assets, liabilities of any person, firm, association or corporation;
- H. To borrow money of any person, firm or corporation and to issue bonds, debentures or obligations of this corporation from time to time for any of the objects or purposes of the corporation and to secure the same by mortgage, pledge, deed of trust or any other lawful means with property of the corporation;
- I. To do any and all things necessary, suitable or proper for the accomplishment of any of the purposes, for the attainment of any of the objects, for the exercise of any of the powers herein set forth, whether specified herein or not;

The several causes contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall in no way be limited or restricted by reference to, or inference from, the terms of any other clause, but shall be regarded as independent purposes and powers; and no recitation, expression or declaration of specific or special powers or purposes herein expressly declared shall be deemed to preclude powers

or purposes not so declared, and that all other lawful powers not inconsistent herewith are hereby included.

IV.

The location and post office address of the registered office of the corporation shall be 435 Highway 30 E. Kimberly, Idaho and the registered agent is Craig Hawker at the same address.

V.

The number of directors of this corporation shall be not less than three directors, except that in cases where all shares of the corporation are owned beneficially and of record by either one or two stockholders, the number of directors may be less than three, but not less than the number of stockholders. The names and address of the directors are as follows:

There shall be one class of capital stock of the corporation and it shall be known as common stock. The par value of the authorized capital stock shall be the amount of \$100,000 divided into 1,000 shares at the par value of \$100.00 per share, all of said stock to be non-assessable.
