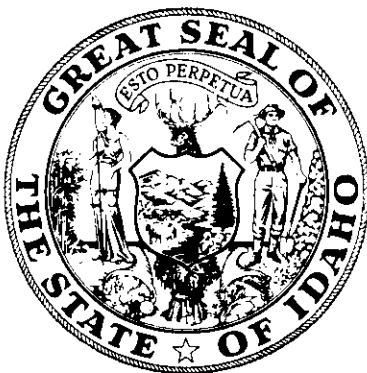

FIFTH: All debts, obligations, and liabilities of the Corporation have been paid and discharged, or adequate provision has been made therefor.


SIXTH: All of the remaining property and assets of the Corporation have been distributed to the sole Shareholder in accordance with his respective rights and interests.


SEVENTH: There are no suits pending against the Corporation in any court.
