ARTICLES OF INCORPORATION.
OF THE
SNAKE RIVER LAND AND CATTLE COMPANY -
LIMITED.

KNOW ALL MEN BY THESE PRESENTS,

That the undersigned do hereby voluntarily associate
ourselves together, for the purpose of organizing a Corporation under the
laws of the State of Idaho, and do hereby certify-

Article I.

The name of the Corporation is the SNAKE RIVER LAND AND CATTLE
COMPANY-LIMITED.

Article II.

1. The purposes for which this Corporation is formed are- Of estab-
lishing and conducting a general Land and Live Stock business, within the
State of Idaho, and other States and Territories, holding property therein
and incorporating for that purpose, under and in pursuance of the laws of
the State of Idaho.

2. To own and acquire by purchase or otherwise, Land, Land leases,
Cattle, Horses, Mules, Jacks, Hogs, Sheep and Goats, and to pasture and herd
Cattle, Horses and Sheep for compensation.

3. To own and acquire by purchase or otherwise, Water Rights, Water
Ditches, Plumes, Wind Mills, Pumps; together with any other apparatus or device

used in hoisting or elevating water for watering Stock, irrigating lands or otherwise.

4. To carry on and maintain a general butchering business, wholesale and retail, to pack, ship or keep the products of the butchering business, and to erect, own, purchase and maintain Cold Storage plants, in all its branches.

Article III.

The principle place of business of said Corporation, shall be Boise, Idaho.

Article IV.

The period for which this Corporation shall exist, is thirty (30) years.

Article V.

The number of Directors of this Corporation shall be seven, and the names and residences of those appointed for the first year are as follows, to-wit:-

The Capital Stock of this Corporation is ONE HUNDRED THOUSAND DOLLARS, divided into ONE THOUSAND shares, of the par value of One hundred dollars each.
