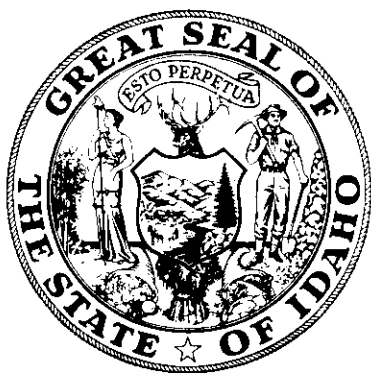

ARTICLES OF INCORPORATION
OF
BARRETT, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, acting as incorporators under the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

SECTION 1:

The name of the corporation is BARRETT, INC.

SECTION 2:

The period of its duration is perpetual.

SECTION 3: Corporate Purposes:

The purpose or purposes for which the corporation is organized are: Security Systems, safe and lock, and Real Estate together with all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

SECTION 4: Stock:

The aggregate number of shares which the corporation shall have authority to issue is 300,000 shares of common stock at the par value of \$1.00 per share.

SECTION 5: Corporation Regulations:

The internal affairs of BARRETT, INC., shall be regulated by such by-laws as may be provided for the corporation and in addition shall be regulated in accordance with the provisions of the Idaho Business Corporation Act, Section 30-1-23(a).

SECTION 6: Registered Office:

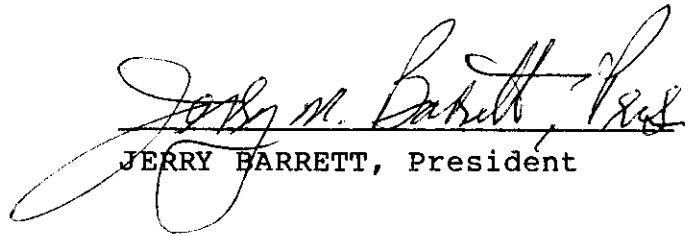
The address of the initial registered office of BARRETT, INC., is 735 East Chubbuck Road, and the name of its initial registered agent is JERRY BARRETT.

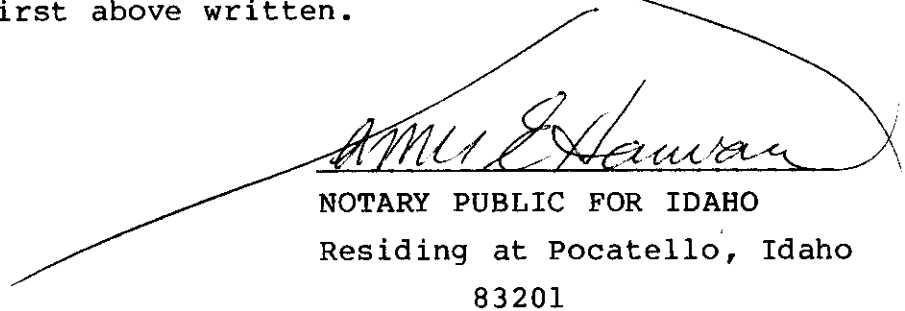
