AMENDED AND RESTATED ARTICLES OF INCORPORATION OF WARD'S CHEESE, INC.

Pursuant to the provisions of § 30-1-61 of the Idaho Business Corporation Act, the undersigned Corporation Majores Mines #4119 ing Second Amendment to the Amended and Restated Afficles of Incorporation:

SECRETARY OF STATE

FIRST: The name of the Corporation is Ward's Cheese, Inc.

SECOND: The Corporation amended and restated its Articles of Incorporation on June 5, 1989. The Amended and Restated Articles of Incorporation were filed in the office of the Secretary of State of the State of Idaho on June 12, 1989 at 8:50 a.m., Mountain Daylight Time.

TRIRD: The following amendment to the Amended and Restated Articles of Incorporation was adopted by the sole shareholder of the Corporation effective as of May 7, 1991 in the manner prescribed by the Idaho Business Corporation Act. Article I is amended as stated below.

FOURTE: Article I is amended to read in its entirety as follows:

The name of the Corporation is Avonnore West, Inc.

FIFTH: The number of shares of the corporation outstanding at the time of the adoption of this Second Amendment to the Articles of Incorporation was 910,000; and the number of shares entitled to vote thereon was 910,000.

SIZTE: The number of shares which voted for adoption of this Second Amendment to the Amended and Restated Articles of Incorporation was 910,000; and the number of share which voted against adoption of this Second Amendment to the Amended and Restated Articles of Incorporation was 0.
